- HARD ESKIES OF ANY SIZE/TYPE (INCLUDING FOAM ESKIES)

- BALLS, INCLUDING BUT NOT LIMITED TO TENNIS, CRICKET, FOOTBALLS
- WEAPONS, GUNS & KNIVES (OR ANY OTHER OBJECT THAT COULD BE USED AS A WEAPON)
- SIGNS/BANNERS/CLOTHING OR ANY OTHER ITEM DISPLAYING COMMERCIAL, POLITICAL, RELIGIOUS OR OFFENSIVE MESSAGES OR LOGOS
- SIGNS/BANNERS/CLOTHING OR ANY OTHER ITEM INTENDED FOR THE ENGAGEMENT OF AMBUSH MARKETING
- PROFESSIONAL STANDARD STILL/VIDEO CAMERAS AND RECORDING DEVICES
- UMBRELLAS
- SHADE COVER STRUCTURES
- BICYCLES
- PETS
- ANY ITEM WHICH COULD REASONABLY BE DEEMED TO CAUSE PUBLIC NUISANCE OR OFFENCE TO ANY USER OF THE VENUE
- FLAG POLES OVER 1 METRE IN LENGTH
- NON SACA APPROVED CUP HOLDERS

MUSICAL INSTRUMENTS WILL BE PERMITTED AT THE DISCRETION OF VENUE MANAGEMENT.

PATRONS SHOULD ALSO REFER TO CRICKET AUSTRALIA'S CONDITIONS OF ENTRY TO THE VENUE FOR CRICKET EVENTS.

PATRONS ARE ADVISED THEY ARE ENTERING A LICENSED PREMISES AND ARE THEREFORE REQUIRED TO COMPLY WITH THE FOLLOWING LIQUOR LICENSING LAWS;
